THIS IS TO CERTIFY that the amended articles of incorporation of the

(Amending Article VII thereof)

copy annexed, adopted on <u>July 19, 2019</u> by a majority vote of the Board of Directors and by the vote of the stockholders owning or representing at least two-thirds of the outstanding capital stock, and certified under oath by the Secretary and a majority of the Board of Directors of the corporation was approved by the Commission on this date pursuant to the provision of Section 15 of the Revised Corporation Code of the Philippines, Republic Act No. 11232, which took effect on February 23, 2019 and copies thereof are filed with the Commission.

Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing company, pre-need plan issuer, general agent in pre-need plans and time shares/club shares/membership certificates issuers or selling agents thereof. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

AMENDED ARTICLES OF INCORPORATION OF CARD PIONEER MICROINSURANCE INC.

KNOW ALL MEN BY THESE PRESENT:

That we, all of whom are of legal age, citizens in the Philippines, on this date had voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the Philippines.

AND WE HEREBY CERTIFY:

First: - That the name of said Corporation shall be:

CARD PIONEER MICROINSURANCE INC.

(As amended on June 26, 2013)

Second: - That the purpose for which said Corporation is formed are:

- To insure houses, tenements, merchandise, other property and effects, real and personal against loss or damage by fire, storm, earthquakes, accidental or otherwise, and to carry on the ordinary business of fire insurance in all aforesaid branches. To rebuild. repair, replace reinstate houses. buildings, machinery and every other description of property which may be insured by the Company and to carry on any kind of business necessary or expedient for any such purpose.
- (b) To insure against every description of marine risk, which may be legally undertaken, relating to the perils of the sea, fire, war, reprisals, and all other risks of a like nature incidental to the seas, ships, vessels, and water craft of all descriptions, and also the freights, goods, or board of the same, whether the property of the stockholders of the Corporation or not, so far as the same may be affected or made by according to law. To insure all other matters and things which lawfully may or can be, from time to

time, insured or be the subject of insurance against perils of the sea, and also generally to carry on other branches and departments of the insurance business.

- (c) To grant either in the Philippines or abroad, policies or other instruments of insurance against or compensation or payment in case of death or injury to health or limb by railway or airplane accident or shipwreck or other perils of the land, sea, air or any other accident or misadventure, violence during any journey or voyage by land or water air, or during any other limited or specified period; and to provide prepare. and supply medicine and surgical aid and treatment or any other assistance in case of accident or harm to any person whom the Company shall insure or to any person dwelling or staying in the house of such person insured.
- (d) To reinsure any or all rights of the Company and to undertake all kinds of reinsurance and counterinsurance connected with the business of any other Company.
- (e) To guarantee the fidelity of persons holding places of public or private trust and to agree to the faithful performance of any contract or undertaking made with any public authority.
- (f) To guarantee the performance of contracts, agreements, agreements, undertakings, obligations, promises or duties, of all kinds other than minsurance policies.
- (g) To guarantee the performance of insurance contracts where surety bonds are accepted for such purpose.
- (h) To guarantee title to property.
- (i) To execute and guarantee bonds and undertakings of all kinds, required or permitted to be taken in any or all

actions, proceedings, negotiations, importations, exportations, or other transactions or operations, either by private individuals, or by heads of departments, courts, judges, officers, boards, or bodies, whether administrative, executive or legislative or judicial.

- (j) To guarantee and indemnify professional practitioners from loss, damage or liability unto third persons in relation to the exercise of their profession.
- (k) To guarantee and indemnify merchants, traders, and those engage in business and giving credits, from loss or damage by reason of giving or extending such credit to their customers or persons dealing with them.
 - (I) To indemnify against loss by burglary, theft, forgery, embezzlement, or by any one or more of such happenings.
 - (m) To insure glass against breakage.
- (n) To guarantee and indemnify the owners and users of steam boilers and pipes, or fly wheels, engines of all kinds or machinery, against explosion or other accident and against loss or damage to life or property resulting therefrom, and against loss of use or occupancy caused thereby, and against liability unto third persons by any of said causes; and to make inspection of, and to issue certificates of inspection upon such boilers, pipes, fly wheels, engines or machinery.
- (o) And generally, to execute, sign and carry out fidelity bonds and surety undertakings, of every nature and kind usual in the business of fidelity and surety companies, or permitted by law unto such companies.

- (p) Insofar as may be necessary to accomplish its purpose, to lend money on such terms as may be expedient, subject to the requirements of law.
- (q) To purchase or otherwise acquire and undertake all or any part of the business, property and liabilities of any person or company carrying on any business which this Company is authorized to carry on or possess or property suitable for the purposes of this Company.
- (r) To acquire by purchase and to invest in, hold, sell, or otherwise dispose of the stocks or bonds, or any interests in either, or any obligations or evidences of indebtedness of any corporation or corporations, domestic or foreign, or the bonds of other obligations or evidences of indebtedness, or any person, firm or corporation and while the owner of such stocks, bonds, or interests therein, or other obligations or evidence and privileges of ownership including the right to vote thereon or consent in respect thereof for any and all purposes.
- (s) To purchase or otherwise acquire, sell, lease, convey, mortgage, and otherwise deal with any property or interest therein, or easement right or privilege over or in respect of any property, real or personal, as may be permitted by law and as may be reasonably necessary to enable it to carry out the purposes for which the Corporation is created as may now or hereafter be permitted by law.
- (t) To procure the Company to be registered or recognized or to be permitted or allowed to carry on its business or any branch or branches thereon in any state, territory, or possession of the United States and/or in any foreign country or places; and carry on its business to do any and all acts and things and exercise any and all powers which a natural person could do or exercise which now is or may, hereafter, be authorized by law.

- (u) To do all or any of the above things in any place in which the Company may determine as principals, agents, contractors, trustees or otherwise, and by or through trustees, agents, or otherwise and either alone or in conjunction with others.
- (v) To do all or any other of the above things as are incidental or conducive to the attainment of the above objects.
- (w) To do and perform any and all of the acts and things and to exercise all of the general powers conferred by law upon Corporations similarly organized and usually and ordinarily incidental to companies of like nature and kind.
- (x) And in general. engage in the to business insurance and guarantee in any branches except in life insurance business, or a consideration, to indemnify person, firm or corporation against loss, damage or liability arising from an unknown or contingent event, and to guarantee liabilities and obligations of any person, firm or corporation, and to act as agent of other insurance or surety companies, in any of its branches, including life insurance.

Third: - That the place where the principal office of the corporation is to be established, or located at Pioneer House Makati, 108 Paseo de Roxas, Legaspi Village, Makati City. (As amended on 26 June 2014)

Fourth: - That the term for which said Corporation is to exist is for another fifty (50) years from August 15, 2013 as amended on June 26, 2013.
