AMENDED ARTICLES OF INCORPORATION OF THE PIONEER INSURANCE & SURETY CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, all of whom are of age and residents of the Philippines have voluntarily associated ourselves together for the purpose of forming a CORPORATION under the laws of the Philippines, and

- WE DO HEREBY CERTIFY -

FIRST : - That the name of this Corporation is

" PIONEER INSURANCE & SURETY CORPORATION ".

SECOND : - That the purposes for which this Corporation

is formed are as follows: (As amended on Nov. 24, 1964)

- (a) To insure houses, tenements, merchandise, and all other property and effects, real and personal, against loss or damage by fire, storm, earthquake shock, fire resulting from earthquake, accident or otherwise, and to carry on the ordinary business of fire insurance in all the aforesaid branches. To rebuild, repair, replace or reinstate houses, buildings, machinery and every. other description of property which may be insured by the company and to carry on any kind of business necessary or expedient for any such purpose.
- (b) To insure against every description of marine risk, which may legally undertaken, relating to the perils of the sea, fire, war, reprisals and all other risks of a like nature incidental to the seas, ships, vessels, and ter craft of all descriptions, and also the freights, goods merchandise, cargo, and all property whatsoever in or on board, of the same may be effected or made according to law. To insure all other matters and things which lawfully may or can be from time to time insured or be the subject of insurance against perils of the sea, and also generally to carry on any other branches and departments of the insurance business.
- (c) To grant either in the Philippines or abroad, policies or other instruments of assurance against or insuring compensations or payments in case of death or injury to health or limb by railway or airplane accident or shipwreck or other perils of the land, sea, or air, or any accident or misadventure, or violence during any other timited or specified period, and to prepare, provide, and supply medicine and surgical aid and treatment or any other assistance and all remedies and requirements in case of accident or harm to any person or the family and household of any person whom the company shall insure or to any person dwelling or staying in the house of such person insured.

(d) To reinsure all or any risks of the company and to undertake all kinds of reinsurance and counter-insurance connected with the business of any other company.

- (e) To guarantee the fidelity of persons holding places of public or private trust and to agree to the faithful performance of any contract or undertaking made with any public authority.
- (f) To guarantee the performance of insurance contracts, agreements, undertakings, obligations, promises, or duties, of all kinds other than insurance policies.
- (g) To guarantee the performance of insurance contracts where surety bonds are accepted for such purposes.
- (h) To execute and guarantee bonds and undertakings of all kinds, required or permitted to be taken in any or all actions, proceedings, negotiations, importations, exportations, or other transactions or operations, either by private individuals, or bodies, whether executive, legislative or judicial.
- (i) To guarantee and to indemnity merchants, traders and those engaged in business and giving credit, from loss or damage by reason of giving and extending such credit to their customers or persons dealing with them.
- (j) To indemnity against loss, by burglary, theft, forgery, embezzelement, or by any one or more such happenings.
- (k) To insure glass against breakage.
- (I) To guarantee and to indemnify the owners and users of steam boilers and pipes, of fly wheels, engines of all kinds or machinery, against explosions of other accident and against loss of use or occupancy caused thereby, and against liability unto third persons by any of inspection upon, such boilers, pipes, fly wheels, engines and machinery.
- (m) And generally to execute, sign and carry out fidelity bonds and surety undertakings of every nature and kinds usual in the business of fidelity and surety companies, or permitted by law unto such companies.
- (n) To lend money on such terms as may seem expedient, subject to the requirements of law.
- (o) To purchase or otherwise acquire and undertake all or any part of the business, property and liability of any person or company on any business which this company is authorized to carry on or possess or property suitable for the purpose of the company.
- (p) To acquire by purchase and to invest, hold, sell, or otherwise dispose of the stocks or bonds, or any interest in either, or any obligation or evidences of
- Oindebtedness, of any person, firm or corporation, and while the owner of such stocks, bonds or interests therein, or other obligations or evidences of indebtedness, to exercise including the right to vote thereon or consent in request thereof for any and all purposes.

- (q) To purchase or otherwise acquire, sell, lease, convey, mortgage, encumber, and otherwise deal with any property or interest of any property, real or personal, as may be permitted by law and as may be reasonably necessary to enable it to carry out the purposes for which the corporation is created as may now or hereafter be permitted by law.
- (r) To procure the company to be registered or recognized or to be permitted to or allowed to carry on its purposes or business or any branch or branches thereof in any state, territory, or possession of the United States and/or in any foreign country or places, and in carrying on its business to do any and all acts and things and exercise which now or bereafter may be authorized by law.
- (s) To do all or any of the above things in any place in which the company may determine as principals, agents, contractors, or trustees or otherwise, any by or through trustees, agents, otherwise and either alone or in conjunction with others.
- (t) To do all such other things as are incidental or conducive to the attainment of the above objects.
- (u) To do and perform any and of the acts and things and to exercise all of the general powers conferred by law upon corporations similarly organized and usually and ordinarily incidental to companies of like nature and kind.
- (v) And in general, to engage in the business of insurance and guaranty in any branches except in life insurance business, for consideration to indemnify any person, firm or corporation against loss, damage or liability arising from an unknown or contingent event, and to liabilities and obligations of any person, firm or corporation and to act as agent of other insurance or surety companies, in any of its branches with the exception of life insurance.

THIRD :- That the central or principal office of the corporation shall be located and established at Pioneer House Makati, 108 Paseo de Roxas, Legaspi Village, Makati City; but the Board of Directors may establish and maintain such branch offices within or without the Philippines as may be deemed convenient or necessary for the business of the corporation. (As amended on 24 June 2014)

FOURTH : - That the term for which said corporation is to exist is for another FIFTY (50) YEARS from and after May 13, 2004. (As amended on 31 January 2003)

SEVENTH : - <u>That the capital stock of the Corporation is Ps300,000,000 and said</u> <u>capital stock is divided into 3,000,000 shares at the par value of Ps100.00 per share.</u> (As amended on 18 April 1994).

Any stockholders who shall be desirous of selling any of his shares in the corporation shall first give the remaining stockholders previous notice in writing of his intention to sell his stock or stocks and the remaining stockholders shall have ten (10) days from the receipt of such notice within which to purchase such stock or stocks at such prices and under such terms that the said stockholder may have been offered by any outsider or non-stockholder, but if none of them decides to exercise the right to purchase, then the selling stockholder is at liberty to sell such stock or stocks to third persons. A list of the names and addresses of stockholders of record of the corporation shall be furnished the intended selling stockholder by the corporation upon the written request of the said stockholder.

That no transfer of stock which shall reduce the ownership of Filipino citizens to less than the required percentage shall be allowed or permitted to be recorded in the proper books and this restriction shall be indicated in the stock certificates.

EIGHT : - That the amount of capital stock which has been subscribed is FIVE HUNDRED AND THIRTY THOUSAND PESOS (Ps 530,000), and the following persons have subscribed for the number of shares and have paid the amount of capital stock set out after their respective name and have further agreed to pay and have actually paid the amount indicated herein below as "Contributed Surplus".
